
1. Roll call, and establish quorum.

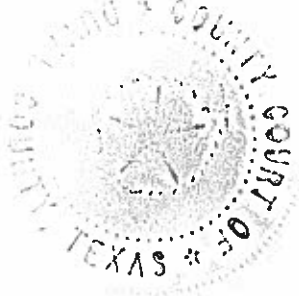
