Motion carried with all members voting "Aye" Against "None."

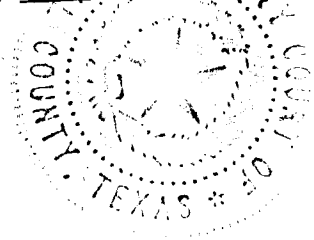
