10. On a motion made Comm. Perez and seconded by Comm. Uribe that we adjourn. Motion carried with all members voting "Aye" Against "None".

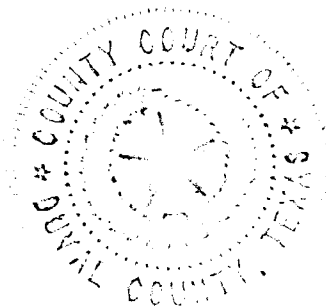
