12. On a motion made by Comm. Uribe and seconded by Comm. Guerra that we approve the cost of the following, utilizing ARP Recovery funds:

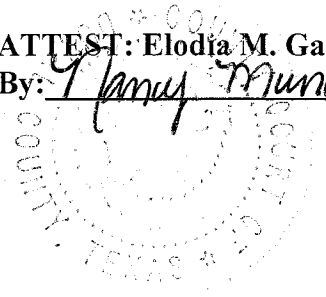
- A. Additional \$120,000.00 for generator for Duval County Sheriff's Office
