1. On a motion made by Comm. Uribe and seconded by Comm. Perez that we approve the Property Tax Rate at \$1.03 being set for General Fund at \$0.760790, Special Road and Bridge at \$0.143989, Farm to Market/Flood Control at \$0.120971, and Vocational at \$0.010104 for Duval County for 2019-2020. Motion carried with all members voting "Aye" Against "None."
2. On a motion made by Comm. Uribe and seconded by Comm. Perez that we adopt the Duval County Budget for fiscal year 2019-2020 with the amendments. Motion carried with all members voting "Aye" Against "None."
3. On a motion made by Comm. Garza and seconded by Comm. Perez that we table to approve the General Order. Motion carried with all members voting "Aye" Against "None."

Perez that we approve an additional \$3,000.00 annual salary supplement, for a total of \$8,000.00 , allocated from the Forfeiture budget, to Lidiana C. Corona, Legal Assistant for the 229th Judicial District Attorney, effective Oct. 1, 2019. Motion carried with all members voting "Aye" Against "None."

6. On a motion made by Comm. Garza and seconded by Comm. Uribe that we approve the attached 2019-2020 Chapter 59 Forfeiture Budget. Motion carried with all members voting "Aye" Against "None."




9. On a motion made by Comm. Garza and seconded by Comm. Uribe that we approve Line item transfer. Motion carried with all members voting "Aye" Against "None."
