

PROPOSED PROPERTY TAX RATE FOR DUVAL COUNTY

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for Duval County from the same properties in both the 2020 tax year and the 2021 tax year. The combined county tax rate of \$0.943499 per \$100 valuation has been proposed by the governing body of Duval County. (Preceding year tax rate: \$0.943004)

The voter-approval rate is the highest tax rate that Duval County may adopt without holding an election to seek voter-approval of the rate.

The proposed tax rate for the County General tax does not exceed the no-new-revenue rate. The proposed tax rates for the Road and Bridge and Farm to Market (R&B and FM) are greater than the no-new-revenue tax rate but do not exceed the voter-approval rate. This means that Duval County is proposing to slightly increase R&B and FM property taxes for the 2021 tax year based on valuation increases. The governing body of Duval County proposes to use revenue attributable to the tax rate increase for the purposes of infrastructure, road and street improvements.

A public hearing on the proposed tax rate and budget will be held on August 23, 2021 at 10:00 o'clock a.m. and consideration for adoption on September 1, 2021 at 10:00 o'clock a.m. at the Duval County Courtroom, 400 East Gravis Avenue, San Diego, Texas 78384.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

Property tax amount = (tax rate) x (taxable value of your property) / 100
