COUNTY OF DUVAL, TEXAS DECLARATION OF LOCAL STATE OF DISASTER DUE TO PUBLIC HEALTH EMERGENCY

- WHEREAS, beginning in December 2019, a novel coronavirus, now designated as SARS-CoV2 which causes the disease known as COVID-19, was detected in mainland China, and has since spread throughout the world; and
- **WHEREAS**, the World Health Organization declared COVID-19 a worldwide pandemic on March 11, 2020; and
- **WHEREAS**, the symptoms of COVID-19 can range from mild to severe illness and cause further complications including death; and
- WHEREAS, COVID-19 virus mainly spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes; and
- WHEREAS, on March 13, 2020, the Governor of the State of Texas issued a proclamation certifying that COVID-19 poses an imminent threat of disaster in the state and declaring a state of disaster for all counties in Texas; and
- WHEREAS, Duval County, Texas, is taking extraordinary measures to prevent the spread of this potentially devastating disease in our community; and
- WHEREAS, said state of disaster requires that certain emergency protective measures be taken pursuant to the Texas Disaster Act of 1975 relating to Emergency Management and Public Health, pursuant to Chapter 418 of the Texas Government Code.

NOW THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE AND APPROVED BY THE COMMISSIONERS' COURT OF DUVAL COUNTY, TEXAS:

- **SECTION 1.** That a local state of disaster for public health emergency is hereby declared for DUVAL COUNTY, Texas, pursuant to Section 418.108(a) of the Texas Government Code.
- **SECTION 2.** That pursuant to Section 418.108(b) of the Texas Government Code the state of disaster for public health emergency shall continue from the date of this declaration until the public health emergency ceases to exist as determined by proper authorities.
- **SECTION 3.** That pursuant to Section 418.108(c) of the Texas Government Code this declaration of a local state of disaster for public health emergency shall be given prompt and general publicity and shall be filed promptly with the County Clerk.
- **SECTION 4.** That pursuant to Section 418.108(d) of the Texas Government Code, this declaration of a local state of disaster activates the Duval County, Texas, emergency management plan, and authorizes the furnishing of aid and assistance under the declaration.

SECTION 5. That this declaration authorizes the County to take any actions necessary to promote health and suppress the virus, including the quarantine of persons and occupied structures, examining and regulating hospitals or clinics, regulating ingress and egress from the County, regulating ingress and egress to occupied structures, establishment of quarantine stations, emergency hospitals, and other hospitals, and insuring compliance for those who do not comply with the County's rules and directives.

SECTION 6. That this declaration hereby limits the size of gatherings to not more than 10 people and mandates the cancellation of all such gatherings of more than 10 people until further notice. A "gathering" refers generally to a scheduled event or common endeavor where t0 persons are present in a confined space, room, or area. (see attached)

SECTION 7. In accordance with Texas Government Code §418.173, a person who knowingly or intentionally violates this declaration commits an offense, punishable by a fine up to \$1,000.00 or confinement in jail for a term that does not exceed 180 days.

SECTION 8. That this declaration hereby authorizes the use of all lawfully available enforcement tools.

SECTION 9. That this declaration shall take effect immediately from and after its issuance and, with approval by the Commissioners Court, shall continue in effect until terminated by the County Judge. Pursuant to this declaration, additional directives may be issued by the County Judge at any time as deemed necessary.

This Proclamation by Gilbert N. Saenz, County Judge for the County of Duval, State of Texas is ratified and approved by a majority vote of the Commissioners' Court for Duval County, Texas and attested to by the Duval County Clerk this 19TH day of March, 2020.
